DISCUSSION

Bob Benecke – Grant Applications, PILOT Programs

Grant Applications

Mr. Benecke stated the \$1.8 million and \$200,000.00 grant applications are ready and will be submitted – submission deadline is October 31st. The \$1.8 million grant is for roads and the \$200,000.00 is for the CSO plan – allocated towards Mott MacDonald fees. The grants do not in any way help the tax levy issue. Resolutions authorizing the grant applications are on the consent agenda tonight.

Mr. Benecke reminded the Board of Commissioners that the Village can bond for \$6 million over the next two years - \$4 million in 2022 and \$2 million in 2023.

PILOT Programs

Mr. Benecke discussed the redevelopment projects from Sturm, KABR, and Hampshire.

He advised the Hampshire project will not happen unless Bogota approves it. Bogota would receive less tax revenue with this project.

Lot coverage on the KABR project doesn't matter – can be cured with a redevelopment plan amendment. Attorney Boggia stated that Ken Ochab (Village Planner) did not think the KABR plan would get denied even with its deficiencies.

Mr. Benecke stated with Skymark gone, both the old and new tax money is gone. 3% of tax base is gone.

Mr. Benecke advised the Sturm project has a 60% chance of happening.

At this time, Mr. Benecke left the meeting.

COMMISSIONER REPORTS

Mayor Anlian advised the Veterans Day ceremonies will be on November 11th at 11am at the Euclid Avenue monument. This Saturday is the Street Fair 10am-5pm.

Mayor Anlian advised he met with Homeland Security regarding the utilization of one officer.
