I, FOR MYSELF AND ON BEHALF OF MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN, HEREBY RELEASE, INDEMNIFY AND HOLD HARMLESS, THE VILLAGE OF RIDGEFIELD PARK, ITS ELECTED AND APPOINTED OFFICIALS, COMMISSIONERS, OFFICERS, AGENTS AND/OR EMPLOYEES, SPONSORING AGENCIES, SPONSORS, ADVERTISERS ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
