A RESOLUTION OF THE VILLAGE OF RIDGEFIELD PARK INITIATING THE COMPETITIVE CONTRACTING PROCESS, AND AUTHORIZING THE ISSUANCE OF A REQUEST FOR QUALIFICATIONS FOR PAYROLL SERVICES

WHEREAS, the Village of Ridgefield Park is in need of a provider of Payroll Services; and

WHEREAS, the Village is seeking the services of a professional and experienced firm to perform this service; and

WHEREAS, the Board of Commissioners for the Village of Ridgefield Park is authorized under N.J.S.A. 40A:11-4.1(i) to use the competitive contracting procedure for procurement of professional services; and

WHEREAS, competitive contracting allows the Village to evaluate and score respondents based on weighted criteria, including technical, management and cost related criteria to ensure that the most professional operator is obtained to meet the needs of the Village.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners for the Village of Ridgefield Park, that the competitive contracting process for provision of Payroll Services for the Village of Ridgefield Park; and

BE IT FURTHER RESOLVED, that the Village Clerk is hereby authorized to solicit qualifications for the provision Payroll Services to the Village, through public advertisement.

A Resolution Awarding a Contract to D&L Paving Contractors, Inc. for the Overpeck Avenue Island Reduction Project

Whereas, The Village of Ridgefield Park has been selected to receive funding from the New Jersey Department of Community Affairs (NJDCA) for road projects, in the amount of \$1,800,000.00 toward the construction costs; and

Whereas, The Village wishes to remove and reduce the overall width of the existing roadway islands and repair cracking and/or damaged concrete roadway areas on Overpeck Avenue; and

Whereas, the Village in accordance with the laws of the State of New Jersey, publicly advertised for the receipt of bids under specifications prepared by Boswell Engineering for this project, as set forth in Resolution No. 2023-123; and

Whereas, the Village received five (5) bids for the above referenced roadwork and each bid was reviewed by the Village Engineer on February 22, 2024, which included the bid tabulations for each; a copy of this correspondence is on file with the Village Clerk; and

Whereas, after such bid review and based upon the recommendation of the Village Engineer, the Village has determined that D&L Paving Contractors, Inc. is the lowest responsible bidder for this contract in the amount of \$651,546.08, which includes the Base Bid and the Alternate Bid; and

Whereas, the Village Chief Financial Officer has certified that funds have been appropriated and are available for this purpose, a copy of said certification attached to the original copy of this Resolution.

Now, Therefore, Be It Resolved by the Board of Commissioners of the Village of Ridgefield Park that a contract is hereby awarded to D&L Paving Contractors, Inc. in the amount of \$651,546.08, which contract includes both the Base Bid and the Alternate Bid as per the bid specifications prepared by Boswell Engineering.

Be it Further Resolved that:

- 1. The Mayor (or Commissioner-in-Charge) and the Village Clerk are hereby directed, authorized and empowered to execute a contract with D&L Contractors, Inc. in a form satisfactory to the Village Attorney and to take all steps reasonably necessary to effectuate the provisions and purposes of this resolution.
- 2. All other Village officials, officers and employees are hereby directed, authorized and empowered to take all steps reasonably necessary to effectuate the purposes and provisions of this resolution.
