Resolution 2025-37

RESOLUTION AWARDING CONTRACT TO D.L.S. CONTRACTING, INC., FAIRFIELD, NJ FOR THE ROAD RESURFACING, RECONSTRUCTION AND DRAINAGE PROJECT FOR PARK STREET FROM OVERPECK AVENUE TO EUCLID AVENUE AND THE PAVING OF WEBSTER STREET PARKING LOT

WHEREAS, The Village of Ridgefield Park advertised for the receipt of bids for the Road Resurfacing, Reconstruction, and Drainage for Park Street and the paving of Webster Street Parking Lot; and

WHEREAS, the proposed contract work is set forth in the bid specifications prepared by Boswell Engineering dated January 10, 2025, a copy of which is on file with the Village Clerk; and

WHEREAS, six (6) bidders submitted proposals for the above referenced work, which bids were reviewed by the Village Engineer by letter dated March 14, 2025; and

WHEREAS, the Village Engineer has determined that D.L.S. Contracting, Fairfield, NJ 07004, is the lowest responsible bidder for each base bid and each alternate bid. DLS is the low bidder in all combinations of both base and alternate bids with a total cost of \$332,402.00 as follows:

Base Bid 1 - Park Street - \$269,027
Base Bid 2 - Webster Parking Lot - \$39,015
Alternate Bid A - Civic Center - \$3,795
Alternate Bid B - Municipal Lot - \$20,565

Total - \$332,402; and

WHEREAS, The Village of Ridgefield Park has been selected to receive funding from the New Jersey Department of Transportation (NJDOT) 2024 Municipal Aid Program for road resurfacing of Park Street, from Overpeck Avenue to Euclid Avenue, designated LA-2024 MA 02 in the amount of \$270,109.00 toward the construction costs of \$332,402.00, and

WHEREAS, the Village of Ridgefield Park has accepted this grant by Resolution 2024-160, passed September 10, 2024; and

WHEREAS, the Chief Financial Officer has certified herein that funds have been appropriated and are available for this purpose in account number 04-2150-55-2401.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Village of Ridgefield Park, County of Bergen and State of New Jersey in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., the contract is awarded to D.L.S. Contracting Inc., 36 Montesano Rd., Fairfield, NJ 07004 based on the Engineer's recommendation dated March 14, 2025; and

BE IT FURTHER RESOLVED that a copy of the resolution be forwarded to the CFO, the Village Clerk, the Engineer, and the vendor for their records.

Resolution 2025-38

A Resolution Authorizing the Award of an On-Line Recreation Management Contract to CivicPlus, under State Contract No. V00005089

WHEREAS, the Village of Ridgefield Park has a need to enter into a contract for Recreation Management services; and

WHEREAS, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-12(a) and N.J.A.C. 5:34-7.29(c), a municipality may by resolution and without public advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the Village of Ridgefield Park intends to enter into a contract in the amount of \$10,491.08 with CivicPlus, 302 South 4th St., Ste 500, Manhattan, Kansas 66502, which company is a State Contract Vendor, ID No. V00005089, subject to properly executed contracts, which shall be subject to all the conditions applicable to the current State Contract; and

WHEREAS, the Commissioner of Parks and Public Property, has recommended that a contract be awarded as set forth herein, based upon the proposal submitted, a copy of which is attached hereto.

WHEREAS, the Chief Financial Officer of the Village of Ridgefield Park, as required by N.J.A.C. 5:30-1, certified that there are sufficient funds available for the purpose of awarding a contract to said entity, to encumber funds against:

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners of the Village of Ridgefield Park, that a contract be awarded to CivicPlus, for provision of Recreation Management services, for an initial term of twelve (12) months, at \$10,491.08; and

BE IT FURTHER RESOLVED that the Mayor, Commissioner of Parks and Public Property, Village Clerk, and any other necessary Village official are hereby authorized to execute a contract consistent with the provisions of this resolution.
