**April 22, 2025**  
**7:30 PM**

**COMMISSIONERS REPORTS**

**Commissioner Anlian** advised the Arbor Day ceremony will take place on Saturday, April 26<sup>th</sup> at 10AM in Brewster Park. They will be dedicating some trees in honor of Ptl. Steven Fernandez. The DPW has replanted 77 flowering trees in Brewster Park.

**Commissioner Gerken** wished all a Happy Earth Day since today is actually Earth Day. The Main Street planters have been refreshed by the Village Gardeners, who could always use new help.

**Commissioner Portorreal** advised the children’s Easter Egg Hunt took place last Saturday. Sustainable RP had a recycling event at the DPW – next one is in October. Pool Open Houses are May 3<sup>rd</sup> 10am-2pm and May 14<sup>th</sup> 6pm-8pm. First 50 members will receive a gift.

**Mayor MacNeill** advised the budget was introduced on April 17<sup>th</sup>. The municipal portion of taxes will increase \$155, Board of Education portion will increase \$360 and the County portion will increase \$20, for a total of approximately \$535 on the average assessed home of \$430,000.00. The Civic Rec program will launch May 5<sup>th</sup> – scheduling of fields and Municipal Building use.

## **INTERN REPORT**

Liam McAveney – 15X Survey

Mr. McAveney, a student at Ramapo College, is currently an intern with the Village of Ridgefield Park. He has been assigned to conduct a Shuttle Interest Survey of the Ridgefield Park residents due to NJ Transit obtaining undeveloped land in the Village.

There were 127 responses to the survey. The results showed there is a need for enhanced public transit services. More than half of the responders who answered the question ‘if a shuttle existed where would you like to see it go?’, offered either 15X as their preferred location or variants of ‘train station.’ 70% of the survey respondents would prefer to use the shuttle for work purposes.

The survey is still open for residents to participate.

Frank Donaruma, resident, stated he had recommended to the Board of Commissioners to ask the US Senators for an Environmental Impact Study from the EPA pertaining to a NJ Transit bus depot.

Commissioner Gerken advised a NJ Transit plan has yet to be designed.

## **HEARING OF CITIZENS**

Karen Purpura, resident, is co-chair of the RP Arts Association. She voiced her concern that there is not much art in Ridgefield Park anymore – Public Arts Committee, Creative Placemaking, the Grove Street piano and concerned that the arts budget was cut.

Mr. Purpura is very concerned that the arts are diminishing in the Village.

Mayor MacNeill advised Commissioner Mirza is the Commissioner in charge of the arts and he is not here tonight.

Commissioner Anlian advised the Village will continue conducting Summer Concerts - there is a concert tomorrow at the Knights of Columbus.

Frank Donaruma, resident, stated he was advised that the Civic Center is no longer usable for musicians – must pay a fee. Arts are essential for our quality of life. There have been economic studies done on the benefit of the arts.

Mr. Donaruma brought up that there is no bank in town.

Commissioner Anlian advised that he has met with a few banks and they feel they won’t make any money, they don’t want the public’s money.

Commissioner Gerken added the whole environment has changed.

Mr. Donaruma asked why one of the community gardens was closed. Commissioner Anlian stated both gardens are open – a fence was put up around McGowan Park’s garden since people were helping themselves.

Mr. Donaruma stated with the Arts Champions not having meetings is a direct conflict to the Master Plan.

Mayor MacNeill advised Mr. Donaruma and Ms. Purpura to voice their concerns to Commissioner Mirza, since the Arts is his department.

Mr. Donaruma asked if the new laundromat is putting in a dry well. There is a 12- inch pipe and the water has to be going somewhere.

Daniel Terranova, resident, requested an update on the Veterans Park renovations.

Mayor MacNeill advised the project is still in the environmental stages – the DEP is involved and the land is undergoing studies, test pits for the water table level. Once the wetlands are delineated, the design phase can begin. The Village has 2 engineering firms involved and a landscape architect. The Village cannot do anything without the DEP’s approval.

**April 22, 2025**

Eliana Sevilla, resident, asked for a time line on the Veterans Park development. Mayor MacNeill advised there is no time line; hopefully close to the design stage. Unfortunately, this is out of our hands.

### **ORDINANCE PUBLIC HEARING & ADOPTION**

- 2025-08 AN ORDINANCE BY THE BOARD OF COMMISSIONERS AMENDING THE VILLAGE CODE OF RIDGEFIELD PARK TO REPEAL CHAPTER 193; TO ADOPT A NEW CHAPTER 193; TO ADOPT FLOOD HAZARD MAPS; TO DESIGNATE A FLOODPLAIN ADMINISTRATOR; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE
