SPECIAL REPORTS

Installation of the Ridgefield Park Volunteer Ambulance Corps. Officers.

Commissioner Poli asked Captain Zapata to give his annual report.

Captain Zapata stated as of December 20, 2012, the Volunteer Ambulance Corps. responded to 1,137 Emergency Calls, a 24% increase from the previous year. Holy Name Hospital responded to 57 of the Village calls in 2012, a 7% decrease from the previous year. The Corps. has received 49 new adult members and 7 new youth members. The Corps worked closely with the other Emergency Services in the Village during Hurricane Sandy. Training continues to be a top priority for the Corps. They are anticipating another successful year in 2012. He then asked the Board of Commissioner to consider increasing their budget.

Captain Zapata thanked the Commissioners, Police Department, Fire Department, Rescue Squad, OEM, DPW, and the Clerk's office.

Commissioner Poli thanked the Captain and asked Mrs. O'Grady to administer the oath of office to the Lieutenants, Mechanic, and Administrative Officers of the Volunteer Ambulance Corps.
