Hearing of Citizens: None present.

Activity reports were as follows:

Bowling – Nothing to report.

Wrestling – No activity at this time.

Girls' Softball - Lloyd Domke said the season is going well and the girls appear to be having fun.

Women's Softball – Peggy Schneider is running the program for the Board again. Equipment has been ordered and distributed. Games have started. There are eight teams in the league this year. The teams were reminded that lights must be out at 10:00 p.m.

Fourth of July – There have been two nominations for grand marshal so far, Harold Butler and Elizabeth McCormick.

Easter Egg Hunt – The egg hunt was held on April 19. Mary Koegel had plenty of help available. Community service students from the high school assisted this year and were very helpful. There was one special needs child this year in one of the divisions that could have used the assistance of a parent. There were some children that participated in the younger division because parents' felt they needed parental assistance but they were too old to participate with the younger children. Next year children must participate in their own division or skip the hunt. There was some discussion that next year it might make the youngest division easier for all children to get an egg if everyone was lined up in a circle so all children had an egg in front of them. There were plenty of eggs this year.
