

NEXT REGULAR MEETING: WEDNESDAY, OCTOBER 17, 2001 AT 6:00 P.M.

MINUTES OF THE RP HISTORIC PRESERVATION COMMISSION

September 19, 2001

Chairman Al Zaccone called the meeting to order at 6:01 p.m., it having been duly noted that notice of this meeting has been published in accordance with the rules of the Sunshine Law. Roll call was taken. Commission members present were: Al Zaccone, Edwin Holmberg and Mary Romme. Ed Arcari arrived at 6:02 p.m. after roll call was taken.

The minutes of the August 15, 2001, meeting were approved.

New Business: None submitted.

Old Business: None submitted.

Correspondence and Notes: Commissioner John Anlian advised Al Zaccone that file cabinets will be in the municipal building on Monday for use by this Commission.

Al Zaccone advised that Hugh Boyd was supposed to mail something out to him regarding the guidelines but he still has not received anything. As soon as Al Zaccone receives this information, there will be a meeting between Commissioner Anlian, Hugh Boyd and himself to agree to the guidelines and have them published.

Al Zaccone noted that nothing has been done to Wireless Village concerning their storefront. A letter will be sent asking when this work will be done in accordance with the Commissioner's approval. Mary Romme noted that nothing has been done to 99c Store either. A letter was sent to this business in August.

At this time, Sonnia Feldstein arrived at the meeting. Mrs. Feldstein resubmitted her application for a new sign for **David's Vintage Place, 221 Main Street**. She proposes to install a new metal sign, 2 feet x 10 feet. The sign will be the same size as the adjacent Wags to Whiskers sign. The background will be a medium blue with white lettering. There will be a small blue angel in the corner of the sign. The sign will cover the entire top area of the storefront and will be mounted recessed into the brickwork. There will be no other signs on the building or the windows.

Al Zaccone made a motion, which was seconded by Mary Romme, that the sign is approved as submitted in a size of 2 feet high x 10 feet wide, which would match the sign of the adjacent store, Wags to Whiskers; the sign will cover the

exposed wood surface and fit within the brick panel that is supplied for it and the colors would be white lettering on a mid-blue to match the sample that has been submitted; the sign will be vinyl or painted lettering on a metal sign and that the sign be permanently affixed to the building. A building permit will be required for the sign. All were in favor of this motion. It is clear there is no other signage being applied for and the sign will not be lighted. Approval is for the sign only.

As far as the trees on Main Street, Al Zacccone heard that the trees would be trimmed immediately after July 4th. Al Zacccone will check into this as businesses are complaining that their signs are not visible due to the trees.

There being no further business the meeting adjourned at 6:15 p.m.
