# **NEW BUSINESS**

Challenger Road Redevelopment

Mr. Ken Ochab, Ochab Assoc., presented to the Board. The Challenger Road Redevelopment is an amendment for the property across from the theater which the Village owns. The amendment is requested so the proposed project will fit into the Redevelopment Plan and can go forward. The Commissioners have reviewed the project.

The proposal is for a forty-six story building with a mix of a 200 room hotel with 400 residential units.

The Board discussed the proposed project.

Mark Olson asked to add an Arts District to the Redevelopment Plan Resolution to the Board of Commissioners.

Mr. Rosen read the Planning Board Amended Re-Development Resolution into the Record. The Board added two additional recommendations to the Resolution, one that a provision be made within the re-development sites to provide for inclusion of public art and culture and one to limit the overall height of the buildings to be consistent with the existing buildings on Challenger Road.
