Resolution 2021-13

WHEREAS, the Village of Ridgefield Park currently owns (one) **2011 Ford Police Interceptor Sedan, 4 door vehicle, a 2015 vehicle bearing manufacturer Vin# 1FAHP2MK8EG145586** which had been used by the Police Department and has a value generally of less than THREE Thousand and 00/100 (\$3,000.00) Dollars; and

WHEREAS, said vehicles are surplus vehicles and are no longer needed by the Police Department or any other department in the Village of Ridgefield Park; and

WHEREAS, the Village of Ridgefield Park finds it is necessary to dispose of said vehicle at public auction in accordance with N.J.S.A. 40A:11-36; and

WHEREAS, the Village of Ridgefield Park is a member of Municibid Online Auction Services; and

WHEREAS, it is the best interest of the Village of Ridgefield Park to have the municipality's property listed and offered for sale.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Board of Commissioners of the Village of Ridgefield Park that it hereby authorizes the sale of the surplus vehicle to the winning bidder on the Municibid Online Auction.

BE IT FURTHER RESOLVED that the surplus vehicles be sold in "as is" condition and that the Village makes no representations of warranties as to the condition of the vehicles.
