Whereas, the Village of Ridgefield Park has a need to procure certain equipment for use by the Department of Public Works; and

Whereas, consistent with P.L. 2011, c.139, and N.J.S.A. 52:34-6.2(b), the Village is desirous of awarding this contract through a national cooperative purchasing agreement; and

Whereas, the Superintendent of the DPW did solicit a quote from Storr Tractor Company under the National Joint Powers Alliance/Sourcewell ("Sourcewell") Cooperative Purchasing Agreement, which the Village had previously joined as a member; and

Whereas, Storr Tractor Company submitted a proposal for the provision of the Ventrac Tractor, under Contract #031121-TTC, in the amount of \$47,811.97; and

Whereas, consistent with P.L. 2011, c.139, the DPW Superintendent did conduct a cost savings determination justifying the award of this contract under a national cooperative contract; and

Whereas, Storr Tractor Company will be required to submit to the Village a copy of its New Jersey Business Registration Certificate, Statement of Corporate Ownership, and Public Contract EEO Compliance, as well as all required political contribution disclosure forms, prior to execution of a contract; and

Whereas, the Village provided notice to the public and potential bidders of its intention to make this award by way of a Notice of Intent to Award a Contract under a National Cooperative Purchasing Agreement, a copy of which notice is on file with the Village Clerk, in advance of this award; and

Whereas, the Village Chief Financial Officer has certified that funds have been appropriated and are available for this purpose.
