Resolution No. 2022-28

A Resolution Awarding a Professional Services Contract to Piazza & Associates, Inc. to Serve as the Village's Administrative Agent Concerning Affordable Housing Units

WHEREAS, the Village of Ridgefield Park has a need to procure professional services from a firm to serve as the Village's Administrative Agent concerning Affordable Housing units in the Village; and

WHEREAS, the Village of Ridgefield Park has received a proposal (the "Proposal") from Piazza & Associates, Inc. ("Piazza") to provide the necessary services to the Village; and

WHEREAS, the funding for the services provided to the Village under said contract shall come from the Village's Affordable Housing Trust Fund, with most of the cost of the services performed by Piazza being borne by the owners/sponsors of the affordable housing units; and

WHEREAS, the Village is desirous of awarding this contract to Piazza in accordance with the terms set forth in the Proposal, subject to approval and execution of a formal contract acceptable to the Village; and

WHEREAS, although the value of this contract is not anticipated to be in excess of \$17,500 (the Village pay-to-play threshold), this contract has been awarded under the "alternative process" pursuant to *N.J.S.A.* 19:44A-20.4 et seq. (the "Pay-to-Play Law"), and has been awarded to Piazza based upon the merits and abilities of Piazza to provide the services necessary; and

WHEREAS, although this contract has been awarded under the "alternative process," Piazza has completed and submitted a Business Entity Disclosure Certification which certifies that Piazza has not made any reportable contributions (\$300 or more) to a political or candidate committee in the Village of Ridgefield Park with the elected officials in the previous one year, and that the contract will prohibit Piazza from making any reportable contributions (\$300 or more) through the term of the contract; and

WHEREAS, the *Local Public Contracts Law*, *N.J.S.A.* 40A:11-5, requires the resolution authorizing the award of contracts for professional services without competitive bids and the contract itself to be made available for public inspection; and

WHEREAS, pursuant to *N.J.S.A.* 40A:11-5, public notice of this contract award shall be published in the official newspaper of the Village in accordance with applicable law; and

WHEREAS, the Village's Chief Financial Officer has certified that funds have been appropriated and are available for this purpose.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Village of Ridgefield Park that a professional services contract is hereby awarded for service as the Village's Administrative Agent concerning affordable housing, in accordance with the terms and conditions set forth in the Proposal, as follows:
