WHEREAS, Celebration has completed and submitted a Business Entity Disclosure Certification which certifies that Celebration has not made any reportable contributions (\$300 or more) to a political or candidate committee in the Village of Ridgefield Park in the previous one year, and that the contract will prohibit Celebration from making any reportable contributions (\$300 or more) through the term of the contract; and

**WHEREAS**, the Chief Financial Officer has certified that funds have been appropriated for this purpose and are available in Account Number 01-2010-30-4202-114 Patriotic Celebrations – Fireworks.
