Resolution 2022-102

A Resolution Awarding a Contract to D.L.S. Contracting Inc. for the Ridgefield Park 2022 Road Improvement Program

WHEREAS, the Village of Ridgefield Park has a need to procure road paving services for the Village streets that consists of the following:

Base Bid 1 - Main Street

The milling and resurfacing of Main Street from Hobart Street to Summit Street.

Base Bid 2 – East Grand Avenue and Preston Street

The milling and resurfacing of East Grand Avenue from Teaneck Road to High School Parking Lot and Preston Street from Overpeck Avenue to High School Parking Lot.

Base Bid 3 – Alpine Court

The milling and resurfacing of the entire length of Alpine Court.

WHEREAS, the Village of Ridgefield Park, in accordance with the laws of the State of New Jersey, publicly advertised for the receipt of bids under specifications for the "2022 road Improvement Program"; and

WHEREAS, three (3) bids were received on August 16, 2022; and

WHEREAS, after receipt and review of the three (3) lowest bids received, the Village of Ridgefield Park has determined that D.L.S. Contracting Inc. is the lowest responsible bidder for this contract for the Base Bid (Base Bid 1 + Base Bid 2 + Base Bid 3); and

WHEREAS, the Chief Financial Officer of the Village has certified that funds have been appropriated and are available for this purpose in account number 04-2150-55-2203-001, a copy of said certification attached to the original copy of this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Village of Ridgefield Park that a contract is hereby awarded as follows:

D.L.S. Contracting Inc. of Fairfield, NJ is the low bidder with a Base Bid (Base Bid 1 + Base Bid 2 + Base Bid 3) of \$657,656.32. The qualifications submitted by D.L.S. Contracting Inc. are in compliance with bid specifications.

BE IT FURTHER RESOLVED that the Mayor and Village Clerk are hereby directed, authorized and empowered to execute all documents necessary to effectuate the purposes of this Resolution, consistent with the Village's bid specifications and applicable law, and subject to approval as to form by the Village Attorney.
