**WHEREAS**, the Village of Ridgefield Park deems it necessary and desirable to provide for a capital project not previously reflected in the 2023 Capital Budget of said municipality, and

**WHEREAS**, N.J. A.C. 5:30-4.4B provides that the Capital Budget of a governing body shall be amended to reflect any provisions, changes or inconsistencies with said Capital Budget,

**NOW, THEREFORE, BE IT RESOLVED** by the Commissioners of the Village of Ridgefield Park, in the County of Bergen, State of New Jersey, that the 2023 Capital Budget shall be amended to reflect the addition of Ordinance 2023-11 – IMPROVEMENT OF THE SANITARY SEWERAGE AND STORM WATER DRAINAGE SYSTEMS (CSO PROJECT) in the amount of \$8,000,000.00, not previously provided for in the Capital Budget.

**BE IT FURTHER RESOLVED** that the attached form, as promulgated by the Local Finance Board shall represent the amended Capital Budget for the year 2023.
