RESOLUTION REQUIRING PLANNING BOARD ATTORNEY AND ATTORNEY TO THE BOARD OF ADJUSTMENT TO SUBMIT MONTHY VOUCHERS FOR PAYMENT OF ANNUAL COMPENSATION

WHEREAS, <u>N.J.S.A.</u> 40:55D-42 allows for the Village of Ridgefield Park Planning Board to contract and fix compensation for legal counsel, in an amount not exceeding appropriations made by the governing body for that purpose; and

WHEREAS, <u>N.J.S.A.</u> 40:55-71 allows for the Village of Ridgefield Park Zoning Board of Adjustment to contract and fix compensation for legal counsel, in an amount not exceeding appropriations made by the governing body for that purpose; and

WHEREAS, section 96A-13(b) establishes the offices of Planning Board Attorney and of the Attorney to the Board of Adjustment, and allows each Board to appoint and fix the compensation of their respective Board Attorney; and

WHEREAS, <u>N.J.S.A.</u> 40:55-53.2 places limits on municipal payments for professional services rendered pursuant to the Municipal Land Use Law, which requires certain documentation; and

WHEREAS, the Report of Audit for the Village of Ridgefield Park, dated December 31, 2022, identified that payment of annual compensation for the Planning Board Attorney and Attorney to the Zoning Board of Adjustment are currently being made through the Village payroll system; and

WHEREAS, the Board of Commissioners has been advised by the Auditor that the Planning Board Attorney and the Attorney to the Zoning Board of Adjustment must instead be paid by monthly voucher.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Village of Ridgefield Park, that the Planning Board Attorney's annual compensation in the amount of \$6,631.99 and the Attorney to the Board of Adjustment's compensation in the amount of \$6,699.64 be paid through a monthly voucher in twelve (12) equal payments, to be signed and submitted by each attorney.

BE IT FURTHER RESOLVED, that a copy of this resolution shall be provided to the Planning Board and the Zoning Board of Adjustment, which shall notify their respective attorneys of this voucher system, as required by the Village Auditor.

RESOLUTION AUTHORIZING THE VILLAGE OF RIDGEFIELD PARK TO ENTER INTO A GRANT AGREEMENT WITH THE COUNTY OF BERGEN

BE IT RESOLVED, that the Mayor and Board of Commissioners of the Village of Ridgefield Park with to enter into a grant agreement with the County of Bergen for the purpose of using a \$120,000.00 grant award from the 2023 Funding Round of the Bergen County Open Space, Recreation, Floodplain Protection, Farmland & Historic Preservation Trust Fund ("Trust Fund") for the acquisition of open space property in the project entitled "Ridgefield Park Nature Preserve" located in Block 20.01, Lots 3.03 and 5, on the tax maps of the Village of Ridgefield Park; and

BE IT FURTHER RESOLVED, that the Mayor and Board of Commissioners hereby authorize the Mayor to be a signatory to the aforesaid grant agreement contract; and

BE IT FURTHER RESOLVED, that the Mayor and Board of Commissioners hereby authorize the Mayor to sign all County of Bergen Payment Vouchers submitted in conjunction with the aforesaid project.
