RESOLUTION NO. 2024-13

A Resolution Authorizing the Village of Ridgefield Park to Purchase Two (2) LUCAS 3 Chest Compression Systems Through the Sourcewell Cooperative Purchasing Program in the Amount of \$42,564.20

WHEREAS, the Village of Ridgefield Park Ambulance Corps has determined that there is a need for emergency life saving equipment known as LUCAS 3 Chest Compression Systems and related equipment, i.e. battery charger, external power supply, etc.; and

WHEREAS, N.J.S.A. 52:34-6.2 authorizes contracting units to purchase goods or to contract for services through the use of a nationally-recognized and accepted cooperative purchasing agreement for its administration; and that has been developed utilizing a competitive bidding process by another contracting unit within the State of New Jersey, or within any other state, when available; and

WHEREAS, the Department of Community Affairs Division of Local Government Services issued Local Finance Notice 2012-10 entitled "Using National Cooperative Contracts: Application of P.L. 2011, c. 139." The LFN set forth guidance for contracting units to follow in utilizing a national cooperative contract; and

WHEREAS, the procurement of goods and services through a National Cooperative does not need to go through the public bidding process.; and

WHEREAS, Stryker has been awarded Sourcewell Cooperative Purchasing Program Contract 041823-STY; and

WHEREAS, the Village Ambulance Corps has recommended the utilization of this contract as it represents the best price available per the cooperative pricing agreements bidding procedures and is a cost savings to the Village. A copy of the Stryker proposal is attached hereto and made a part hereof; and

WHEREAS, the Chief Financial Officer of the Village of Ridgefield Park, as required by N.J.A.C. 5:30-1, certified that there are sufficient funds available for the purpose of awarding a contract to said entity, to encumber funds against:

NOW THEREFORE, be it resolved by the Board of Commissioners of the Village of Ridgefield Park, as follows:

- 1. The Village declares that Stryker is formally awarded a contract to purchase two (2) LUCAS 3 Chest Compression Systems and accessories in an amount not to exceed \$42,564.20.
- 2. The Village Purchasing Agent is hereby authorized to purchase goods or services under Contract Number 041823-STY, pursuant to all conditions of the National Cooperative contract.

RESOLUTION NO. 2024-14

A Resolution Awarding a Contract to W.S. King & Son for Demolition of VFW Building on Bergen Turnpike Pursuant to NJSA 44A-20.4, et seq.

WHEREAS, the Village of Ridgefield Park wishes to demolish an unsafe structure owned by the Village, which structure was previously owned and occupied by the Village VFW.; and

WHEREAS, the building and property was deeded to the Village for public purposes as the Village deemed appropriate; and

WHEREAS, the building is in disrepair and has been declared an "unsafe" structure by the Building Department; and

WHEREAS, the Village did solicit quotes for the demolition of the structure.; and

WHEREAS, it was determined that this contract should be awarded to W.S. King & Son, who submitted the lowest bid in the amount of \$34,000.00, which amount is under the bid threshold; a copy of the quote dated September 12, 2023 is attached hereto; and

WHEREAS, this contract is being awarded pursuant to the "alternative process" set forth in N.J.S.A. 19:44A-20.4 et seq.; and

WHEREAS, W.S. King & Son must complete and submit a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political candidate or candidate committee in the Village of Ridgefield Park in the previous one year, and that the contract will prohibit W.S. King & Son from making any reportable contributions through the term of the contract; and

WHEREAS, the Village Chief Financial Officer has certified that funds have been appropriated and are available for this purpose in account no. ______

NOW THEREFORE, be it resolved by the Board of Commissioners of the Village of Ridgefield Park, as follows:

- 1. The Recitals above are incorporated as if set forth herein at length.
- 2. A contract is hereby awarded to W.S. King & Son as set forth above.
- 3. The Mayor (or Commissioner-in-Charge) and the Village Clerk are hereby directed, authorized and empowered to execute a contract with W.S. King & Son in a form satisfactory to take all steps necessary to effectuate the provisions and purposes of this resolution.
