RESOLUTION TO AUTHORIZE THE ISSUANCE OF A CERTIFICATE OF COMPLETION TO 30 CROSS RP URBAN RENEWAL, LLC

WHEREAS, a Redevelopment Agreement was executed between the Village of Ridgefield Park (hereinafter the "Village") and 30 Cross RP Urban Renewal, LLC on November 4, 2022, pursuant to the terms of the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1, <u>et seq.</u> ("Redevelopment Law"); and,

WHEREAS, the aforementioned Redevelopment Agreement involves a parcel of land located at Block 152.01 Lot 1 on the tax assessment map of the Village (hereinafter the "Project"); and,

WHEREAS, it has been determined that the Project has been substantially completed in accordance with the terms set forth in the Redevelopment Agreement; and,

WHEREAS, pursuant to Section 7.02 of the Redevelopment Agreement, a certificate of completion shall be issued upon the substantial completion of the Project Improvements; and,

WHEREAS, Boswell Engineering is the Village Engineer for the Village of Ridgefield Park, and has recommended that a certificate of completion be issued; and,

WHEREAS, the proposed certificate of completion is attached to this resolution as an Exhibit, together with a copy of the Certificate of Occupancy; and,

WHEREAS, the Board of Commissioners have accepted the recommendation of Boswell Engineering, and therefore direct that a certificate of completion be issued to 30 Cross RP Urban Renewal, LLC.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Village of Ridgefield Park, that the Mayor, Village Clerk and all other necessary Village Officials are hereby authorized to execute the certificate of completion attached as an Exhibit herein to 30 Cross RP Urban Renewal, LLC.
